Johnson raised some concerns he has been hurting about the flu shot being mandated. There are real concerns about having to be mandated. There is a theory it will help to relieve some of the stress on healthcare systems. He thinks as a body of the senate they should inquire how this decision has made and what the repercussions are if you do not get the flu shot.

Courtney said this decision was made out of the start team. If there are specific concerns and she can work with students to get those questions answered. She wants to ensure that if a student has a reason for not getting a flu shot, they do not get sent to student conduct.

Johnson said the student body president of the law school is sending a survey to see how they feel about this.

Hall said she completely agrees with Johnson that we should have transparency but wants to make a blanket statement that it is safe and proven to reduce death. Our population is not likely to die from the flu, but others it can be a death sentence for.

Johnson thanked her for the sentiment of encouraging people to get the flu shot, but he thinks forcing people is entirely different. The Tuskegee trials people were injected with syphilis, so this may be a sensitive topic for some people. Mandating that someone has to receive a shot may be too far.

Bilal said that was a great point. He met with the lead of the start team. Their team went back and forth and recommended that they did not recommend any sort of repercussion to the university. Any decision that the university makes would not come from the start team.

Courtney mentioned that the healthcare leader has been working with UK to create an exempt form. When she gets more information, she will send it over.

Taylor Williams said she can give you your flu shot if you want.

Courtney is doing a Facebook live with some people who are over high up and had an impact on the decision for the flu shots.
